Rules & Regulations

1. Ran Kekulu accounts should be individual accounts, not joint accounts.
2. The account should be in the name of the minor.
3. A competent minor (age 16 to 18) may open an account for himself/herself. For minors below 16 years of age the account should be opened by parents or guardian. For foreign currency accounts proof of overseas employment of parent or guardian (legal) should be furnished to the Bank.
4. When the account holder reaches 18 years of age the account will be converted to 18+, NRFC/RFC account depending on the ability of the account holder to satisfy the eligibility criteria relevant to these category of accounts.
5. Deposits to these accounts may be made by any person. Deposits to Foreign Currency Accounts should be in the form of convertible foreign currency by way of drafts, SWIFT, electronic transfer, or a transfer from NRFC account.
6. It is a requirement to submit the birth certificate/NIC to withdraw funds, if the birth certificate has not been submitted at the time of opening the account.
7. No withdrawals/closure of account will be permitted until the minor reaches 18 years of age. Withdrawals/closure of accounts will however be allowed only at the sole discretion of the bank for the purpose or reasons which benefit the minor such as education, medical treatments or marriage etc.
8. In the event of the account holders's demise the balance in the account will be paid to the legal heirs of the account holder.
9. The bank reserves the right to change the above rules at any time and/or to alter the rate of interest.
10. The minimum deposit required to open an account in domestic currency is Rs. 100/- and for foreign currency is US\$ 25 or its equivalent in other designated currency. (subject to change)
